### 1. Key Items to highlight to Governing Body

## 1.1 Performance Report

- 1.2 The report submitted to the Quality and Performance Committee presented the CCG's performance position for February 2021. The dashboard at Appendix A included in the report outlined the most recently published data along with those measures for which data collection was currently suspended. The main body of the report focused on indicators where there was under-performance in the most recently published data.
- 1.3 The Quality and Performance Committee noted the detail as listed as well as being made aware of the detailed work taking place with providers, partners and others across the system with the aim of restoring activity across a number of different areas to pre-Covid levels (where possible). In terms of Urgent Care the Committee was informed that this area was undergoing a programme of redesign and discussions and work would be taking place reviewing how urgent care may be carried out differently across the system. This piece of work involved linking in with interdependencies too.

#### 2. Elective Care Update

- 2.1 The Quality and Performance Committee welcomed this agenda item which provided an update in relation to a number of Elective Care Workshops that had recently taken place (and continue to take place) with a variety of representatives from across the Northern Care Alliance and Bury One Commissioning Joint Transformation Group.
- 2.2 A series of slides were shared with the Committee which presented more detail around;
  - The Problem

- Integrated System Working collaborating to "Build back Better"
- Bury systemwide Roadmap
- 2.3 After the workshops the Committee was advised that it is hoped that defined areas of work would be established and that representatives would form task and finish groups to lead each of the areas along with patients and other representatives involved in order take forward actions and address needs.
- 2.4 The Quality and Performance Committee were advised also that from a quality point of view, the Quality Team were fully engaged in Elective programme and they would be carrying out some deep dives into a couple of key areas ensuring this dovetailed into the work already in the pipeline.
- 2.5 The Quality and Performance Committee were pleased to see this work in progress and requested regular updates be provided at their Committee meetings.

### 3. Nursing Home Assurance Visits – 2020/2021

- 3.1 The Quality and Performance Committee reviewed the report outlining the Nursing Home Assurance Visits for 2020/21. The report provided an overview of the assurance that safeguarding processes and procedures were appropriately in place within care homes with nursing and in line with Bury CCG's statutory responsibilities to ensure the safeguarding of adults within the locality.
- 3.2 The Committee was informed that this was an annual review and overall was a positive report received. They were highlighted to the joint working that had taken place with teams across the CCG, the Local Authority and General Practice and welcomed further opportunities for joint working to take place in order to achieve positive outcomes for patients.
- 3.3 The report was well received and the Quality and Performance Committee recognised the amount of work carried out by the Nursing Homes to ensure safeguarding assurances were in place especially during the pandemic.

#### 4. Social Care Performance

- 4.1 The Quality and Performance Committee were pleased to receive a comprehensive report which provided an overview of Social Care Activity during 2021/21 which ascertained whether the Covid pandemic had any significant impact on demand for services and if so what had been addressed for those needs to move forward.
- 4.2 A number of pages in the report were explained in further detail to the Committee with them recognising the detailed work being carried out and of the continued work in progress. The Quality and Performance Committee said they wished to see sight of this report on a regular basis as they felt this was a useful report of data to have oversight of.

#### 5. **Deep Dive and Risk Report**

Date: 26 May 2021

5.1 The Quality and Performance Committee reviewed in detail the deep dive report in relation to **Autistic Spectrum Conditions Assessment - Neurodevelopmental assessments**. They recognised the work being carried out and progress to date. The Committee agreed that the risk remain the level it was at due to the nature of risk and work required and welcomed further reviews throughout the report period accordingly.

# 5.2 Risk Report - Discontinuation of Priadel from 6th April 2021

The Quality and Performance Committee reviewed the information as outlined in the risk report, noting the risks and the updates provided. They **agreed** with the recommendation that the above risk be closed having taken into consideration the information provided which outlined the following:

The Department of Health and Social Care (DHSC) have identified that there is no longer a need to implement system wide switching of patients from Priadel tablets to an alternative lithium carbonate preparation. Bury CCG & Pennine Care did not

undertake a switching program and therefore this risk no longer poses a threat.
